 Full-year city of New York resident estate or trust – Form IT-205, line 5  
 Part-year city of New York resident trust – Form IT-205-A, line 10, col. (b) **9.**  .

10 If line 9 above is:  
 — \$42,000 or less, enter **.650** (65%)  
 — more than \$42,000 but not more than \$142,000, complete Worksheet B *(on back)*  
 — more than \$142,000, enter **.150** (15%) ..... **10.**

11 Multiply line 8 by line 10. **City of New York resident individuals:** Continue on line 12 below. **City of New York part-year resident individuals:** Stop; transfer line 11 amount to Form IT-360.1, line 54. **Estates and Trusts:** Stop; transfer line 11 amount to Form IT-205, line 22 ..... **11.**  .
