MSF AWARDED 42 EXCELLENCE IN ACCOUNTING SCHOLARSHIPS TO COLLEGE STUDENTS IN THE 2021/2022 FISCAL YEAR. THE SCHOLARSHIPS AWARD \$2,500 TO FULLTIME STUDENTS AND \$1,250 TO PART-TIME STUDENTS.
